FUNGICIDE RESISTANCE WARNING

GROUP M3 FUNGICIDE

For fungus resistance management, Kendon Potato Dust Fungicide is a Group M3 fungicide. Some naturally occurring individual fungi resistant to the product and other Group M3 fungicides may exist through normal genetic variability in any fungal population. The resistant individuals can eventually dominate the fungi population if these fungicides are used repeatedly. These resistant fungi will not be controlled by this product and other Group M3 fungicides, thus resulting in a reduction in efficacy and possible yield loss. Since the occurrence of resistant fungi is difficult to detect prior to use, Kendon Plant Care Pty Ltd accepts no liability for any losses that may result from the failure of this product to control resistant fungi.

PROTECTION OF LIVESTOCK

Treated seed is to be used only for sowing. Treated seed tubers not used for sowing must be destroyed. Do not use treated seed potatoes for food or feed purposes. Treated seed potatoes must be stored apart from other potatoes and bags or containers must be clearly marked, indicating that the contents have been treated with Kendon Potato Dust Fungicide.

PROTECTION OF WILDLIFE, FISH, CRUSTACEA, THE ENVIRONMENT AND OTHERS

Dangerous to fish. DO NOT contaminate streams, rivers or waterways with the chemical or used containers.

STORAGE AND DISPOSAL

Store in the closed original container, in a dry, cool, well ventilated area out of direct sunlight. Shake empty bag into dusting container. Puncture or shred and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

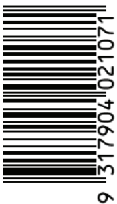
