

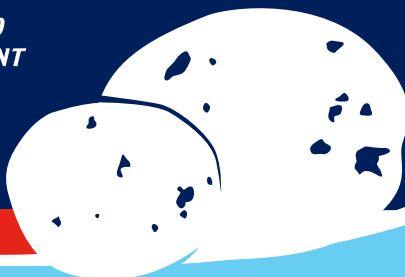

DIRECTIONS FOR USE

RESTRAINTS: DO NOT treat wet, damaged and rotting potatoes. DO NOT treat after sprouting has developed. DO NOT use on or near seed potatoes. DO NOT store treated potatoes near seed potatoes. DO NOT use bags or bins that have contained treated potatoes to store seed.

CROP	RATE	CRITICAL COMMENTS
Stored Potatoes	1.5kg / Tonne OR 100g / 50kg Bag	Dust potatoes evenly. Potatoes should be clean, dry and well matured. For best results treat early after digging.

NOT TO BE USED FOR ANY PURPOSE, OR IN ANY MANNER, CONTRARY TO THIS LABEL UNLESS AUTHORISED UNDER APPROPRIATE LEGISLATION.

GENERAL INSTRUCTIONS: Dust potatoes evenly using a dust blower or dusting bag.

PRECAUTION: RE-ENTRY PERIOD: Do not allow entry into treated areas for 48 hours after treatment. When prior entry is necessary, wear all protective clothing, including respirator. Clothing must be washed after each days use.

PROTECTION OF WILDLIFE, FISH, CRUSTACEA AND ENVIRONMENT: Dangerous to fish. DO NOT contaminate streams, rivers or waterways with the chemical or used chemical containers.

STORAGE AND DISPOSAL: Store in the closed, original container in a dry, cool, well ventilated locked room or place and away from children, animals, food, feedstuffs, seed and fertilisers. DO NOT store in direct sunlight. Shake empty bag into spray tank. DO NOT dispose of undiluted chemicals on-site. Puncture or shred and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

SAFETY DIRECTIONS: Will irritate eyes and skin. Avoid contact with the eyes and skin. Do not inhale dust. When using the product wear cotton overalls buttoned to the neck and wrist, elbow-length PVC gloves, goggles and disposable dust mask covering mouth and nose. If product in eyes, wash it out immediately with water. Wash hands after use. After each day's use, wash gloves, goggles and contaminated clothing.

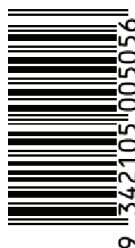
